Membership Qualifications per NTTA By-Laws:

ARTICLE II

Membership

Section 2.01 General. The Corporation shall have three classes of membership – Primary Members, Associate Members and Tribal Members – each class having such rights, duties, and benefits and paying such dues as set forth below or as the Board of Directors shall otherwise determine.

Section 2.02 Qualifications.

(a) Primary membership: Primary Members must be a corporation or other legal entity owned by, controlled by, or organized under the laws of, a federally recognized Indian tribe, band, nation, rancheria, pueblo, colony or community, including any Eskimo or Alaska Native village or any regional, village, urban or group corporation as defined in or established pursuant to the Alaska Native Claims Settlement Act (85 Stat. 688) (a “Tribe”). Primary Members must also be engaged in providing Telecommunications Service, as hereinafter defined, to a Tribe. For purpose of these Bylaws, "Telecommunications Service" shall mean the transmission of signals, writing, images, sounds, messages, data or other information of any nature by wire, radio, lightwaves, electromagnetic means or other similar means.

(b) Associate Membership: Associate Members must be a corporation or other legal entity that does not qualify as a Primary Member but which is engaged in providing Telecommunications Services or in providing support services to entities that provide Telecommunications Service.

(c) Tribal Membership: Tribal membership shall be open to any Tribe, as defined in Section 2.02(a).
