



U.S. Department of Commerce Office of Inspector General Overview

IIJA Funding Programs

Tribes/Tribal Governments are eligible to participate in the following programs:

Broadband Equity, Access, and Deployment (BEAD): expands high-speed Internet access by funding planning, infrastructure deployment, mapping, equity, and adoption programs to all 50 states, Washington, DC and U.S. territories. (\$42.45b)

Tribal Broadband Connectivity Program (TBCP): supports broadband infrastructure deployment, telehealth, distance learning, affordability, and digital inclusion initiatives on tribal lands. (\$2b + \$1b under CAA of 2021)

Digital Equity Act Programs (DE): promotes digital equity and inclusion and aims to ensure that all individuals and communities can acquire the necessary skills, technology, and capacity to engage in the nation's digital economy. (\$2.75b)

Middle Mile Broadband Infrastructure Grant Program (MM): funds construction, improvement, or acquisition of middle mile broadband infrastructure to reduce the cost of bringing high-speed Internet service to unserved and underserved communities by connecting local networks to major networks. (\$1b)






U.S. Department of Commerce Office of Inspector General – Potential Areas of Fraud
