# Tribal Broadband Connectivity Program

## PROGRAM HIGHLIGHTS

**Total Funding pool**  
**\$3.00B**

A program to deploy high-speed Internet in tribal communities.

**The Bipartisan Infrastructure Law (BIL)** added \$2 billion to the existing TBCP and relaxed time requirements of the original program. The Consolidated Appropriations Act of 2021 created the TBCP and allocated \$980 million for high-speed Internet deployment in Tribal communities.

**TBCP NOFO2 closed on 3/22 :**

- ★ Approximately 160+ eligible applicants

- ★ Applications represent \$2B request for Infrastructure Deployment and \$200M+ Use/Adoption



1. Through TBCP NOFO1, 226 awards have been made to date representing:
  1. Over \$1.86 billion in total funding obligated across 390+ Tribes and Tribal Organizations
  2. New broadband connections to over 140K+ households through Infrastructure Deployment and 1,400+ community anchor institutions served.
2. Extensive application of lessons learned through NOFO2 technical assistance including 13 webinars, 14 in-person sessions, and 69 individual TA sessions for Tribes.
3. Implementing updated methods and procedures for application data gathering and processing, curing, application review & quality assurance, and deduplication review for the 160+ TBCP NOFO2 applications.

# Announcements



The Osage Nation hosted national and state leaders in the broadband industry on Monday, March 4, 2024, for Wahzhazhe Connect's groundbreaking on its National Telecommunication Information Administration (NTIA) broadband expansion projects. The event held at Wakon Iron Hall in Pawhuska kicked off construction funded by a \$40.6M federal grant to the Osage Nation.

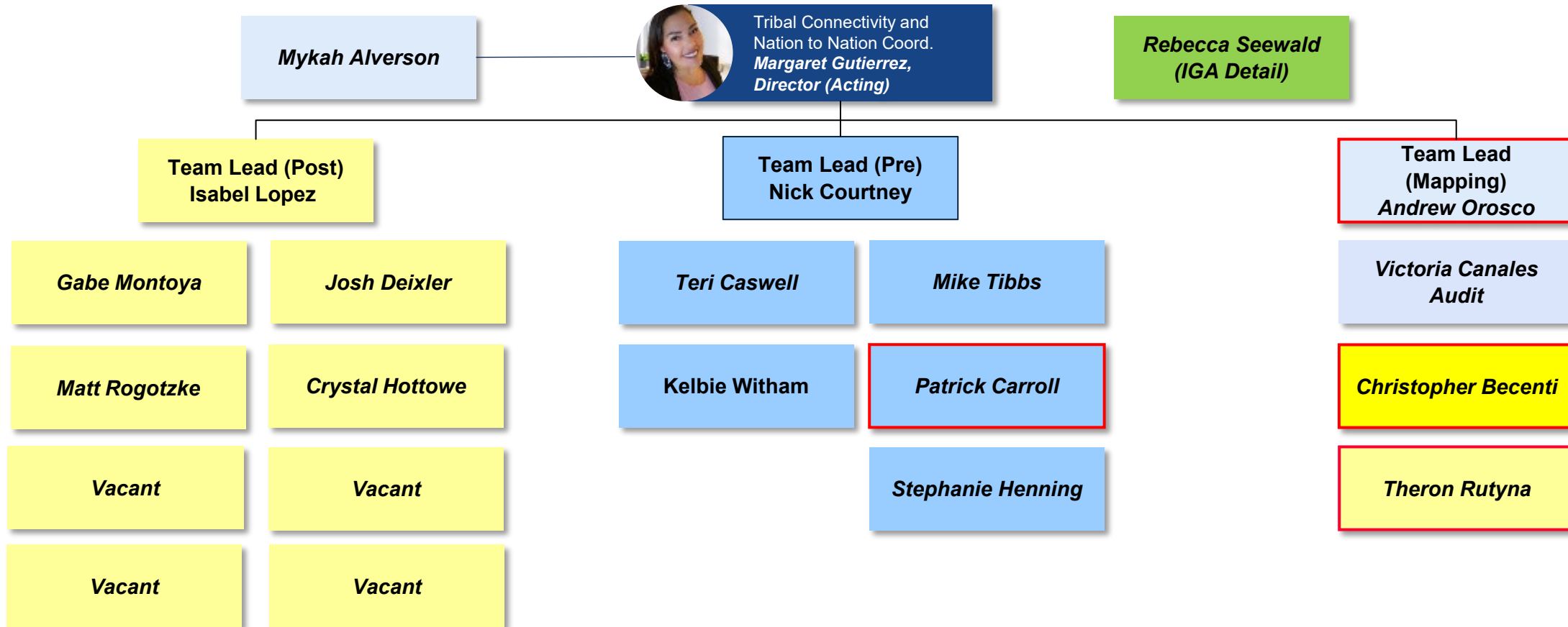

- TBCP 2 applications received:
  - More than 160 applications received
  - \$2.64 billion in total funding requests
  - Approximate \$980 million available from NOFO II
  - Press release available

- The Programmatic Review process is underway
